Resident Membership All the privileges of the Club, including golf, pool, range and clubhouse. Includes the right to bring guests to use the pool and golf course 6 days a week at the prevailing rates.
Dues - \$160/month

Junior/Senior Membership Any person aged 35 or less or 75 and up can receive all the privileges of the Club, including golf, pool, range and clubhouse. Includes the right to bring guests to use the pool and golf course 6 days a week at the prevailing rates.
Dues - \$135/month

Non-Resident Membership Any person who does not have a permanent residence with-in 35 miles of the club will be eligible. All privileges of the Club including golf, pool, range, clubhouse, and guest rights at prevailing rates.
Dues - \$135/month

Social Membership All the privileges of the clubhouse, pool, range and guest rights at prevailing rates. Social members may play golf 6 days/week by paying the prevailing green fees and cart fees.
Dues - \$80/month
